Message from the Executive Director

The Bureau of Developmental Services continues to work with area agencies and provider agencies to prepare for upcoming changes that are part of the system redesign. Two changes that will be starting on July 1, 2023 are how provider agencies contract and bill for services and the requirement for conflict free case management. Services impacted by the direct bill and conflict free coordination changes include waivered services, residential services, community participation services, supported employment services and outreach services.

Direct Billing—In the current system, provider agencies

contract with an area agency and area agencies contract with the state. Area agencies perform the Medicaid billing as part of their contract with the Department of Health and Human Services. As of July 1, 2023 provider agencies will no longer contract with area agencies. This is because The Center for Medicare and Medicaid Services (CMS) now mandates all providers have the choice to bill Medicaid directly. Provider agencies can also use a third-party biller if preferred, but must have the option to direct bill.

The changes needed to establish direct billing require a great deal of work from the Bureau, area agencies and provider agencies. Any agency or entity that provides any ongoing services must be an enrolled Medicaid Provider by July 1, 2023. This will allow the provider to bill Medicaid directly or hire a third-party entity to do their billing. In some regions, area agencies may offer this service.

Many of the current processes and regulations were written based on the area agencies being responsible for contracting with providers and having oversight of services, safeguarding individuals and overall compliance. Regulations such as the Service Eligibility and the Process of Providing Services (He-M 503) must now be reviewed and revised. A new rule specific to provider agencies is being created that will include many of the safeguards and reporting criteria currently included in the contracts between provider agencies and area agencies. The process to change and create these regulations will include an opportunity for public comment. When the time comes, we will be sure to announce it so you will have an opportunity to voice

your thoughts.

Conflict-of Interest Service Coordination—The Centers for Medicare and Medicaid Services (CMS) rules state agencies cannot provide both direct service and case management (Service Coordination) to the same individuals. In New Hampshire, the compliance deadline was extended from 2021 to July 1, 2023 due to COVID-19. These changes will affect you in different ways. If you choose to receive waivered services through one of the Monadnock Developmental Services (MDS) service departments such as MDS-ISO, MCST or Project SEARCH then you will need to use an external agency for your service coordination. If you prefer to keep your current MDS service coordinator, you will need to work with them to find another agency to provide your direct services. Self-directed services may also be in conflict if the agency employs the direct support staff and the service coordinator when that agency also has a role in managing the day to day services.

Please note that this information is current at the time of this writing. As we receive more information we will do our best to keep you updated. Please follow along on the BDS website for the latest information.

Legislative Update

The legislative season is in full swing, with 800+ bills to be acted upon, many of which have the potential to affect those served by MDS. As you are most likely well aware, there are changes coming to the delivery systems of services and the way billing is handled. The Department of Health and Human Services will also upgrade their IT system, which should facilitate greater efficiencies within the department.

Elsewhere in The Clipboard you will read about the Bureau of Developmental Services system redesign, which is a complex issue. Three bills that have been filed in the NH House endeavor to slow the process, and ask for a more thoughtful response to these changes:

- HB238, which would enhance the role of the Developmental Services Quality Council. This bill seeks the requirement that DHHS solicit input from the council on developmental services system change decisions *before* key recommendations are made by department staff or consultant.
- HB317, which would establish a commission to study transitioning to a 2-tier waiver system for individuals eligible for disability services. The bill requests further study, again, before the final recommendation is made to create a system of a 2-tier waiver.
- HB608, which would require DHHS to establish a pilot program to assess the redesign of the BDS. The bill envisions one to three area agencies testing various Alvarez and Marsal concepts prior to a comprehensive roll-out of the redesign program.

There are no public hearings scheduled for these bills at the moment, but they should be taking place soon.

Finally, a bill that will address so-called "legacy budgets" HB642, which prohibits DHHS from enforcing salary caps for direct care workers. This budget will also allow service budgets that are at least two years old to request additional resources for reasonable cost-of-living adjustments.

Self-Directed Services Training

Self-Directed Services are family managed services created to help individuals reach specific outcomes. SDS strives to increase flexibility in service delivery and funding, as well as, to accommodate a variety of consumer needs and preferences.

However, SDS programs are required to follow rules and guidelines established by the State of New Hampshire. Recently, the state has made significant changes to some of the rules and guidelines that affect an individual's funding.

In an effort to assist and educate family members who also act as an individual's program supervisor/ family representative on these changes, the SDS department at MDS is hosting a series of trainings that focus on the relationship between an individual's ISA, budget, progress notes and expense reports. It is critical for everyone affected to understand and implement these changes in order to provide the best outcomes for the individuals who are receiving services.

In addition to topic specific trainings, the SDS department is holding a Q&A session via Zoom on the fourth Wednesday of each month from 12 to 1pm. An MDS employee will be on hand to answer your questions about SDS services.

Self-Advocate Connections – All About Us


The Connections—All About Us self-advocacy group is a safe and friendly group that meets the third Monday of each month via Zoom from 10:30 to 11:30am.

• With staff permission, we will share The Best of MDS achievements through social and print media.


Family Matters: A Council Recap
